

COM/COL APPROVAL

All COM/COL materials must be pre-approved prior to shipping fabric or leather.

All COM material must have a light acrylic or latex backing. COM material must be in one continuous piece. COL in full hides.

Send a 9" x 9" minimum sample of each COM / COL being used on your order, along with the completed application form to:

A separate form should be used for each COM/COL. You will be advised of the amount of material required.

Upon receipt of your completed form and COM/COL sample, we will review the information submitted and contact you with the required yardage or square footage. Circumstances may require a larger sample for approval, or additional yardage/square footage based upon the condition of the goods when received at PBD.
